This notice is to advise holders of Notes that a name and ticker change, has occurred in respect of Yellow Pages Income Fund, one of the Companies whose Shares are included in the Basket of each of the above referenced Notes.

On November 1, 2010, Yellow Media Inc. announced that Yellow Pages Income Fund (the Fund) has completed the previously announced plan of arrangement pursuant to which the Fund's income trust structure has been converted into a dividend paying publicly traded corporation named Yellow Media Inc. Under the plan of arrangement, unitholders of the Fund received, for each unit of the Fund held, one common share of the resulting public corporation. Common shares of Yellow Media Inc. commenced trading on the Toronto Stock Exchange on November 1, 2010 under the symbol YLO.

As a result of the conversion, effective after the close of business on Monday, November 1, 2010, and in accordance with the terms and conditions of the Notes, Scotia Capital, in its capacity as Calculation Agent for the Notes, has removed Yellow Pages Income Fund from the Basket of each of the above referenced Notes and replaced it with Yellow Media Inc. (TSX:YLO).

Capitalized terms used but not defined herein have the meanings ascribed thereto in the relevant Information Statement.
