

# MANAGING CONFLICTS OF INTEREST FROM BEING A MEMBER OF THE SCOTIABANK GROUP OF COMPANIES

Cedar Leaf Capital Inc. ("Cedar Leaf Capital" or "the Firm") is a majority-controlled subsidiary of The Bank of Nova Scotia ("Scotiabank").

Scotiabank and its various financial services subsidiaries are commercial businesses and seek to maximize profits while providing fair, honest and appropriate services to clients. This means we may encourage you to do business with the other members of the Scotiabank group of companies, and we may engage our affiliates to provide us with products and services for your account but will always do so in a way that we consider in your best interests. We will only enter into these transactions or arrangements where they are permitted under applicable securities laws and where we believe they are in your best interests.

Although Cedar Leaf Capital Inc. is under common ownership with the other members of the Scotiabank group of companies and may from time to time have directors, officers and employees in common with these other firms, the Firm is a separate and distinct corporate entity and generally carries on its activities independent of the other firms owned by Scotiabank. However, Cedar Leaf Capital will initially be controlled by, and rely on support and systems from Scotiabank and from time to time there may be certain cooperative business arrangements between it and the other firms, such as arrangements relating to introduction of clients, distribution of products, advisory relationships or administrative support.

In addition to applicable regulatory and contractual provisions respecting any business arrangement that may exist between Cedar Leaf Capital and the other Scotiabank group of companies, the directors, officers and employees of each of the firms are subject to Guidelines or Codes of Conduct governing their actions. These Guidelines and Code of Conduct are supplemented by our internal compliance policies and procedures.

In all cases, the conflicts described in this section raise perceptions that we will favour the business interests of the various members of the Scotiabank group of companies, when the products and services we provide you that are sourced from or provided by those members may not be in your best interests.

These conflicts and how we manage them to ensure that we act in your best interests are described below.

We may receive commissions or other forms of compensation (new issue commission)
when securities are offered for sale for the first time in the primary market and/or through
a secondary offering (new issue) and the securities are distributed by a Scotiabank
affiliate as a member of the underwriting or selling group.

The new issue commission or other form of compensation is paid by the security issuer and/or the selling security holder to Cedar Leaf Capital and/or our affiliate(s).

2. We may sell you securities which we own (called principal trades) and profit by doing so.

We will tell you whether we acted as principal or agent for each transaction on the trade confirmation. We will provide you with a stated yield to maturity for fixed income securities so you can assess the competitiveness of our pricing.



 We may enter into a Referral arrangement from time to time with other members of the Scotiabank group of companies or unrelated Third Parties for purposes of referring an existing or prospective client, for which a referral fee is typically provided to the Referring Party.

You may be referred to Cedar Leaf Capital by another Party, or you may have been referred to another Party that is qualified and registered to offer you investment products, financial services or other services requiring registration not offered by our Firm. It also includes receiving a fee for providing a client name and contact information to an individual or firm.

The amount of any referral fee paid or received for referral services will not affect the fees paid or payable by you. Referral arrangements are disclosed and operated in accordance with applicable securities law and regulatory standards.

### 4. We may Receive Non-Public Information in the Course of Doing Business

Information Barriers and other control processes are in place to safeguard the confidentiality of non-public information the Firm's executives and employees may receive about issuers, customers or other third parties with whom we deal.

Scotiabank maintains "Insider lists" that track access by employee to Sensitive Information through their involvement in a pending deal or transaction in order to manage potential conflicts of interest through the imposition of restrictions on personal or business activities.

Our personal trading policy also requires all CLCI employees to maintain all investment accounts at our affiliated Investment Dealers (ScotiaMcLeod or Scotia iTrade) and we monitor those accounts for inappropriate trading activity.

#### 5. Managing other Conflicts of Interest

Our policies cover other aspects of conflict management, including employee participation in activities outside the firm (e.g. appointments as officers or directors with Public, Not for Profit or Religious organizations; registration with, or providing services to, another registered entity) and the offering or acceptance of gifts and entertainment with third parties with whom the Firm might do business.

Gifts and Entertainment require pre-approval and must be modest in both appearance and amount. We set maximum thresholds for permitted gifts and entertainment so that there cannot be a perception that the gifts or entertainment will influence decision-making.

The Firm may occasionally pay a gift (or honorarium) to Indigenous Elders in appreciation of the sharing of their knowledge, emotional exertion, or personal time, as is customary with Indigenous business relationships. In addition, in the course of the Firm's relationship with the Indigenous Community, Elders and Knowledge Keepers may on occasion seek to offer a gift of cultural significance to the Firm's directors, officer or employees. Often, these gifts are spiritual or sacred to the Indigenous gifter and are not widely marketable in the public domain.



#### CONFLICTS OF INTEREST DISCLOSURE

This Conflicts of Interest Disclosure (Conflicts Statement) sets out important information regarding our material conflicts of interest. These are described in this Conflicts Statement, along with the potential impact on and risk that the conflict could pose to you and how we address the conflict to minimize its impact and risks to you and our other clients. In situations that we do not or cannot avoid a conflict of interest, where our interests may compete with yours, we will always give your interests priority over ours, which allows you to be confident that we address conflicts in your best interest. Generally speaking, we deal with and manage conflicts as follows:

- We avoid conflicts which are prohibited by law, as well as conflicts that we cannot effectively control in your best interest
- We control or manage acceptable conflicts by physically separating Cedar Leaf Capital Employees from other Scotiabank Employees
- For each material conflict, we seek to resolve it in your best interest
- We disclose information about conflicts material to you so that you can assess independently
  if these conflicts are significant to you
- When we participate as an underwriter or as a member of a selling group of securities of a related or connected issuer, we will disclose our relationship to the issuer in the prospectus or other document being used to qualify these securities
