

# SCOTIABANK ALTERNATIVE MUTUAL FUND INDEX

The Scotiabank Alternative Mutual Fund Index ended May 2021 up 0.31% MOM on an equal-weighted basis.

Our index tracks the monthly equal-weighted performance of Canadian Alternative Mutual Funds across constituents classified as Alternative Mutual Funds, as defined by National Instrument 81-102. Given the emerging nature of liquid alternatives, there is no minimum track record, or AUM, required for inclusion in the Index at this time. We are now tracking the performance of 60 funds, split between equity- and credit-focused strategies and are adding new constituents as the market grows.
