DESCRIPTION OF PARAMETERS:

**Start Time** When to begin trading. Default is current time or when market opens if order is entered prior to primary market open.

**End Time** When to stop trading. Default is primary market close time.

**Limit Price** Execute only at a specified price or better.

**Target Volume %** Target to be this percentage of the non-block volume. Allowed to range from 1%-60%.

**Include Interlisted Volume (Canada and U.S. only)** Include volume from both U.S. & Canadian markets on interlisted names. Percent of volume limits will calculate based on combined volume.

**I Would Price** Price at which the algorithm will try and complete the balance of your order (Irrespective of Percentage of Volume (POV) limits).

**At or Above Px** Starting at this price, use Upper Volume % instead of Target Volume %.

**Upper Volume %** Target Volume percentage for upper price range on MPOV orders. Allowed range is 1% – 60%.

**Below This Px** Below this price, use Lower Volume % instead of Target Volume %.

**Lower Volume %** Target Volume percentage for lower price range on MPOV orders. Allowed range is 1% – 60%.

**Max Volume %** Maximum percentage of the market volume to be over the course of the order.

**Benchmark Price** Target price. If entered, treats this as the arrival price instead of the market midpoint.

**Liquidity Seek<sup>†</sup>** Dark, Take, Dark + Take. Grab larger liquidity opportunities at reasonable prices. May use dark pools, taken from lit markets or both. Default is In-line.

**Seek Min. Quantity<sup>†</sup>** Minimum size for liquidity seek to target. Default is to calculate dynamically based on stock and market conditions.

**Style** Liquidity Seek: Passive, Normal, Aggressive. Default is Normal.  
WorkIt: Patient, In-line, Aggressive, Dark Patient, Dark In-line, Dark Aggressive. Default is In-line.  
Dark Smart: Passive, Normal, Aggressive. Default is Normal. Style only applicable for U.S.  
Smart Close: Patient, In-line, Aggressive. Default is In-line.

**Display Mode** Off: Will not post any bids or offers. Peg: Keeps an order on the bid (or ask for sell orders). PegDrop: Keeps an order on the bid (or ask for sell orders). Will never be alone on the best bid or offer. Penny: Keeps an order at the top of book. If the spread is just one tick, it will lift (or hit for sell orders).

**Display Size** If not specified, picks order sizes appropriate to symbol being traded.

**Display Minimum** Only join bids/asks when a minimum number of shares are displayed.

**Join Size**

**Trigger Size** Only take shares if at least this number are available.

**Seek %<sup>†</sup>** The percentage of the order that may be completed using Liquidity Seek. Default is one-third.

**Seek Price** Price at which Liquidity Seek is activated.

**Exchange<sup>†</sup>** Specifies which Canadian Dark exchange order type will be sent for a Dark Smart order.

**Minimum Quantity** Minimum quantity of an order to be executed for Dark Smart orders only.
